### CESSP STAFF REPORT

#### 1) Staff Establishment

- a) CESSP has an approved staff establishment of 51 staff with 41 staff in post. The 41 are distributed in five departments as follows:- Directors Office, Finance, Audit, Operations and Marketing
- b) CESSP complies with Government directive of 30% gender representation as its employees constitute 25 (61%) Male 16 (39%) female.

#### 2) Ethnic and Gender Distribution

- a) CESSP complies with Government directive of 30% gender representation as its employees constitute 25 (61%) Male 16 (39%) female.
- b) The CESSP staff establishment of 41 employees has seven out of the 42 tribes of Kenya represented.
